On 12 May 2023, Richemont announced the initiation of a share buy-back programme which is in effect from 22 May 2023 until 21 May 2026. The buy-back programme is linked to the hedging of exposures arising from the Richemont Long term Incentive plans including the Group's stock option, Richemont Stock Units ("RSU") and Performance Stock Units ("PSU") plans. In compliance with Swiss regulations, the Company is making the following information available regarding share buy-back and sales activity from the start of the share buy-back programme. Other than those shares linked to the exercise of options under the Group's stock option plan, no shares were sold during the period.

The threshold for the daily buy-back volume is 212,727 'A' shares, being 25 % of the daily average during the 30-day period preceding the publication of the current programme.
