Share buy-back programme 2017-2020

The Richemont share buy-back programme is in effect until 14 May 2020.

Share Buy-Back Summary

On 12 May 2017, Richemont announced the initiation of a share buy-back programme which is in effect from 15 May 2017 until 14 May 2020. The buy-back programme is linked to the hedging of exposures arising from the Group's stock option plan. In compliance with Swiss regulations, the Company is making the following information available regarding share buy-back and sales activity from the start of the share buy-back programme. Other than those shares linked to the exercise of options under the Group's stock option plan, no shares were sold during the period.

The threshold for the daily buy-back volume is 445'254 'A' shares, being 25 % of the daily average during the 30 day period preceding the publication of the current programme.
