## Share buy-back programme 2014-2017

The Richemont share buy-back programme is in effect until 15 May 2017.

## **Share Buy-Back Summary**

On 15 May 2014, Richemont announced the initiation of a share buy-back programme which is in effect from 16 May 2014 until 15 May 2017. The buy-back programme is linked to the hedging of exposures arising from the Group's stock option plan. In compliance with Swiss regulations, the Company is making the following information available regarding share buy-back and sales activity from the start of the share buy-back programme. Other than those shares linked to the exercise of options under the Group's stock option plan, no shares were sold during the period.

The threshold for the daily buy-back volume is 303′216 'A' shares, being 25 % of the daily average during the 30 day period preceding the publication of the current programme.
